Mountainside Parents/Guardians and Staff,

Good wishes for a happy and healthy new year to everyone. I hope that you had a nice time off and that your week of remote learning is going well so far!

In preparation for our anticipated return to In-Person Learning on Monday, January 11th, and to ensure the ongoing health and safety of all staff and students, I would like share a few updates and reminders:

- If staff or students traveled outside of New Jersey during the winter break, or this week, they must <u>quarantine for 10 days</u> upon return and prior to returning to school.
 - o Day 1 of the quarantine begins on the day following your return to New Jersey.
 - o Travel to New York, Connecticut, Pennsylvania, and Delaware are exempt from this.
 - o Contact your school nurse directly to discuss and confirm your child's date of return to school.
- If anyone in your household tested positive for COVID-19 over the winter break please notify your school nurse as soon as possible.
- If <u>ANY</u> person in your household has taken a COVID test and is awaiting the result, **your child should <u>not</u> come to school** until the test result comes back and is negative.
- As per guidance from the NJDOH an <u>alternate diagnosis will no longer be accepted</u> for return to school if individuals are absent or sent home for symptoms which meet the COVID-19 exclusion criteria.
 - They will not be allowed to return to school until they have a negative COVID-19 test or meet the criteria for discontinuing home isolation.
- **Siblings** of individuals who have COVID-19 compatible symptoms will be excluded from school for 14 days from date of the last contact or until a COVID-19 negative test is received from the symptomatic individual.
- The NJDOH has updated their guidance to reflect many of these adjustments. Full information and specific details regarding "COVID Exclusion Criteria" can be found here: <u>Guidance for K-12 Schools</u>
- Please complete your child's Health Screening Form in PowerSchool each morning before he/she arrives at school. Your consistency with this is vital in helping everyone get off to a good start each morning!
- Do not hesitate to contact our school nurses about any of the items above or other health related concerns. They have a wealth of knowledge and can help guide you through any questions you may have:

As of today (1/7/2021) the District is aware of the following number of active cases: **Beechwood - 0 / Deerfield - 3***These cases originated outside of school and the timeline indicates there is NO concern for close contact with staff or students within the District.
